That's also a good way to keep them out of sight, so we all can enjoy the beautiful landscapes and surroundings in our neighborhood.

CodeNEXT UPDATE: EVOLVING LAND DEVELOPMENT CODE - David Whitworth, Zoning Committee

The CAG (Code Advisory Group) will break down into three work groups focusing on 1)<u>Code Issues for Affordability</u>, 2)<u>Infill</u>, <u>Compatibility</u>, and <u>Missing Middle Housing</u> and 3)<u>Obstacles for Small Business</u>. Work Group meetings will take place for the next two months, with schedules available at http://www.austintexas.gov/news/working-groups-focus-affordability-compatibility-small-business

Work Group members will include a small number of CAG members each, with additional members invited from various boards and commissions. Public input will be limited after the meeting, although the CAG discussed at the last general meeting a need to better interact in real time with the stakeholders and experts that may be present for work group sessions.

Two additional stakeholder processes will be taking place during the coming months, not scheduled within the link above. They will cover <u>Subdivision Ordinance</u> and <u>Green Infrastructure</u>. The complete schedule is not out, but the Green Infrastructure work group will meet Jan 30th 12:30-2:00 at One Texas Center Rm 325.

Katherine Nicely sat for one CAG meeting as the new member before accepting a staff position with district 2 council member Delia Garza and stepping down to avoid conflicts of interest. The CAG approved a motion by Jim Duncan to recommend Planning Commissioner Nuria Zaragosa for the position should she still be available.

The CAG is set to terminate by the end of Sept. 2015. It may be abandoned, reconfigured, or extended by the new council. To be determined.

There is a draft resolution being discussed by the CAG that would require Opticos to "replicate" existing zoning as an option for future mapping. It would ultimately go up through Planning Commission for approval and recommendation to council. While this seems innocuous, it also raises a question about city charter. City charter requires zoning and code to facilitate the goals of the comprehensive plan. Freezing large swaths of existing zoning in place that does not facilitate the comprehensive plan could be counter to city charter. There currently exists a requirement in the comprehensive plan that any future zoning must "respect" the existing neighborhood plans. While this directive allows for zoning improvements that facilitate the goals of Imagine Austin, like less traffic and more affordability in Austin, it is also understood that zoning changes should be compatible, appropriate, and respect the existing character within the neighborhood plan boundaries. This all arises from the inherent difficulty of trying to create better zoning and mapping within a city that has already been built. The CAG decided to take up the issue again at a future meeting.

We had a banner year with 800 households paying their NWACA dues during the 2014 calendar year. While we are very thankful for the tremendous showing of support, these 800 households represent less than 20% of the households in the NWACA boundary.

- Provides Household Waste (Battery, Oil, Paint and Antifreeze) drop-offs each year
- Produces and delivers a monthly, informative newsletter (yes, this one in your hand or on your computer!)
- Monitors zoning and development issues that affect the neighborhood (the PUD and others)
- Educates and supports us all on Wildlife, Wildfire and other issues that directly impact our area
- Provides about 3000 volunteer hours per year by the 22 NWACA board members that represent your neighborhood

COYOTES: AVOIDING FOOD ATTRACTANTS - Carolyn Abernathy, Wildlife Management Committee

Throughout this year, the NWACA Wildlife Committee will provide education about how to minimize conflict with and damage from coyotes in our neighborhood. Each article will be archived on the NWACA web site for quick and easy access, in the Coyote References files of the Wildlife Management Committee.

Coyotes are opportunistic feeders (scavengers) and food sources are a major attractant in residential areas. Habituation of coyotes to human activity is directly linked to the availability of food resources, including the intentional and accidental feeding of wildlife.

For the safe enjoyment of our yards, parks, and playgrounds, NWACA encourages awareness of food attractants that may be available in your own yard.

If you feed birds:

- Position and monitor feeders so that coyotes and their prey (squirrels and rodents) cannot get to the seed
- Keep seed from accumulating on the ground.
- Clean up after offering any bread and/or table scraps, as this attracts prey.

If you have fruit trees,

• Collect the dropped fruit and don't allow it to accumulate on the ground.

If you compost:

- Make sure compost is secure and that coyotes and their prey (squirrels and rodents) cannot access it.
- Avoid putting meat scraps in your compost.

If you have a pet:

- Feed your pet indoors.
- Store pet food indoors where wildlife cannot reach it.

If you feed wildlife:

Professional literature encourages us NOT to feed wildlife (such as deer, raccoons, squirrels and rabbits).
 Many well-intentioned individuals do so out of kindness and concern for wildlife, without realizing that providing food is also attracting predators. Coyote are highly attracted to your yard because of the presence of wildlife (their prey) - and they are passing through your neighbors' yards to get to yours.
 Quite simply put, the feeding of wildlife contributes to the habituation of coyote in our residential area.
 This compromises the safe enjoyment of our yards, parks, and playgrounds for our pets and young children.

Garbage Storage: Please ensure your cans are enclosed if possible, and that lids are secure.

NWACA policy requires that a property owner obtain an assessment of oak wilt infection, or risk of infection in healthy oaks, from an arborist with ASI oak wilt certification.

REMINDER ABOUT NOT FEEDING THE DEER

Some new neighbors may not be aware that feeding deer is prohibited in Austin. If you see someone feeding deer, let them know that it's bad for the deer and it's a violation of a City ordinance. If the feeding persists, you can report it by calling 3-1-1. The Code Compliance Department will send someone to talk with the neighbor.

FIREWISE TIP OF THE MONTH – BE SURE YOUR HOME IS NOT SOURCE OF FIRE

Each month we feature helpful information about ways to make your home more fire-adapted, better able to prevent wildfire destruction. The full set of tips is archived on the www.nwaca.org web site.

NWACA has been diligent over the past few years in getting the Austin Fire Department, the Texas Forest Service, the City of Austin, Travis County and others to educate all of us in the dangers of urban wildfire. We're learning how to protect our homes, our neighborhoods and our beautiful natural environment from ember storms, wind-blown fire and other natural dangers. Now it is time to discuss the closest danger.....our own homes and poor habits! Embers from a home fire are just as hazardous as those from a wildfire!

As you are probably aware, there have been several serious home fires (individual residences, apartments, condos, etc.) in Austin over the past few years, even some in NWACA boundaries, as recently as last week. Some of the causes of these fires are the fault of the occupants, some due to flaws within the systems of the house, some due to age of the home without proper maintenance and some from natural causes (such as lightening, extremely high winds, etc.). Many of these effects can be eliminated if addressed in a timely manner. We offer the following for your consideration.

First, consider energy systems: electricity (including solar), and natural gas. All of these systems can cause home fires if not installed properly, maintained properly and used properly. It is strongly recommended that you have a reliable electrician inspect your system once a year, particularly the electrical panel boards. Many homes have either copper wiring or aluminum wiring and some have a combination of the two; and they usually are found in the panel boards. The electrician should check all of the lug bolts for service lines coming into these boards and be sure they are tightened securely.

Do not overload individual electrical receptacles with multiple plugs, thus putting too many electrical appliances, etc. on a single receptacle. Bare electrical wires can cause fires and can usually be found in attic spaces, storage rooms and other cavities where rodents can find the wires and chew on them. If you find this happening, do two things: first, call your electrician to inspect and repair, and second, have a pest-control company inspect and treat your home.

Natural gas used by the City of Austin has a very distinct odor. If you use natural gas in your home and if you smell a very distinct odor <u>in</u> your home <u>or</u> around your home, call 311 and/or the gas company immediately and report this occurrence to them. They will come to your house and inspect for a leak. If you have an electric or gas hot water heater in your home, have it serviced once a year by a respectable service company.

The other major system in your home that should be installed properly, maintained properly and used properly is your heating, ventilation and air conditioning (HVAC) system. The primary on-going maintenance for the HVAC system by a homeowner is to change the filters monthly or quarterly (Home Depot and Lowe's both have a wide assortment of HVAC filters). And it is recommended that you have the system inspected by a qualified company twice a year: once in the Spring and once in the Fall (getting ready for cooling in the Summer and heating in the Winter).

Almost every homeowner has a washer and dryer for doing their laundry. It is strongly suggested that you read and follow the manufacturer's maintenance instructions, particularly about cleaning lint from the dryer and the dryer exhaust outlet. There are other appliances in the home that also need to be cleaned regularly, such as refrigerator/freezers and ice makers, which draw air at the floor level and collect significant quantities of lint and "dust bunnies," both of which can be flammable.

Finally, any open flames such as candles and fireplaces are sources for having a fire and should be watched carefully. And everyone already knows about the dangers of smoking in bed.

SILVERFISH - Wizzie Brown, Texas AgriLife

Each month we feature helpful information from the Texas AgriLife Extension Service Program, provided by Program Specialist Wizzie Brown.

I recently noticed silverfish lurking in my house while handling holiday decorations, so I'm sure others may have the same problem. Silverfish can eat and stain books, fabrics, food and wallpaper but are often considered being more of a nuisance than a pest. These insects have flattened carrot-shaped bodies with three long "tails" that



come off the tip of the abdomen. The body is covered with fine scales that give them a silver sheen. Immature silverfish look just like the adults, but are smaller in size.

Usually silverfish are not seen by homeowners because they are most active at night. They can commonly be found in attics, closets or near bookcases. They may also be found behind baseboards or around door and window casings. Silverfish feed on starchy foods like paper, flour, oats or glue.

Tips for managing silverfish:

- Remove old books, papers, and magazines
- Store items in sealed, plastic bags or plastic containers with tight-fitting lids
- Clean closets on a regular basis vacuum/sweep floors and wipe down any shelves
- Reduce humidity with fans, air conditioning or dehumidifiers
- Repair any water leaks
- Inspect all items before bringing them into the house
- Target treatments to where silverfish live wall voids, closets, attics, behind baseboards, etc.

CAN WE SEE YOU? CAN YOU SEE US?

If you're walking or running in the street, are you able to catch the eye of the driver of the car or truck or motorcycle in your lane? On some of our streets, the best place to be is the sidewalk – even if you're not facing the traffic. Be Safe On streets that are marked for bicycles (perhaps also with a parking lane), there's too little space for walkers and bikes and cars; so use the sidewalk if one is available there.

CALL 9-1-1 FOR EMERGENCY ASSISTANCE

The 9-1-1 emergency number gets you a response for a wide variety of issues:

- Life-threatening issues house on fire, person having a heart attack, burglary in progress, etc.
- Health-related crises someone can't catch their breath, incapacitated person needs a lift out of the bathtub, and more.
- If you're unsure, err on the side of caution!

Call 9-1-1 and you will get a quick and kind response from EMS, APD, and Austin Fire Department personnel.

CALL 3-1-1 FOR ASSISTANCE WITH ANY NON-EMERGENCY ACTION BY THE CITY OF AUSTIN

The City of Austin provides one number, 3-1-1, that citizens may call for things like the following:

- Coyote sightings or howling provide an exact street address, so the trapper can locate them
- Reporting trees that have fallen and block roadways or sidewalks, or those that drag on power lines
- Reporting dead animals for pickup; they must be placed at the curb, though; City personnel are not allowed to enter our yards to gather them
- Problems with loose dogs or traffic signals not working
