


#### PUD – What is it?



- Planned Unit Development
- Zoning classification codified in a City Ordinance, a binding agreement between the developer and the City
  - Used to customize regulations to fit the use of a site
  - Requires extra benefits to the City to merit the customization
  - May be supplemented by a Restrictive Covenant with the City, and/or one with the Neighborhood
- 16 PUDs in NWACA
  - Most are residential, most single-family developments
  - The exception; we're sitting in it "the J"

#### Current AO

- 12 office buildings
- Eight 2-story, four 3-story high
- 446,091 sq.ft. developed
- 66% impervious cover
- About 750 trees



## Latest Proposal – April 30



- 7 office buildings and parking structures, at heights ranging from 80 feet (7 story) to 120 feet (8 story)
- 277 units of residential maximum 60 feet
- 1.28M sq. ft. developed
- 50% impervious cover
- 70,000 sq.ft. retail, with 50,000 of it restaurant
- Removing 9 of 72 heritage trees, 22 of 44 protected ones
- 4 acres for park, plus a trails system on site




### Comparison Chart





### 94 NWACA Fires in 2014







#### Our Defense – Firewise



- *Firewise* = A community taking responsibility and implementing actions to protect all its members
- AFD limited resources to protect each life and home
  - AFD firefighters are trained in wildfire and structure fires
  - We must each do our part to protect our lives, lives of our neighbors, and lives of our emergency responders
- We need to harden our homes and landscapes
  - Wooden fences
  - Vegetation too close to windows
  - "Dead and down" material on our property

#### Firewise Defensible Zones





- Zone 1 Home Ignition Zone; home and immediate
   30 feet surrounding; focus here first
- Zone 2 30 to 100 feet from a home. Likely to have trees and underbrush.
- Zone 3 100 to 200 feet from a home; may be thick with trees and underbrush

# Bastrop Fire – September, 2011



### Firewise Home



Bastrop Fire – 1645 homes lost; 1157 survived, many without the aid of suppression – but with a "defensible zone"

# Preventing Wildfire – the NWACA Plan



- Community Wildfire Protection Plans
  - Austin / Travis County Joint CWPP for all areas
  - NWACA plan leverages Joint CWPP implementation
  - NWACA plan deployed by building Firewise Communities throughout NWACA
- Support to new Firewise Communities
  - Coaching from NWACA Firewise Committee and AFD
  - Starter kit plan template, presentation for neighbors
  - Help with mitigation and evacuation planning
  - Free wildfire risk assessments by certified assessors

## What is a Firewise Community?



- Small neighborhood that is fire-adapted
  - HOA or street-level community
  - Tailored plan for specific risks
  - Recognized by AFD, TFS, and nationally
  - NWACA has Meadow Mountain, Estates at the Overlook
- Why is it important?
  - Overall risk decreases as all neighbors address issues
  - Well thought out evacuation plan
  - Additional help and funding to mitigate fuel in Zones 2 and 3, first to those areas that are fire-adapted

125 homes have been assessed; about 4000 more to go!


#### Allen Park

#### Murchison Pool




- \$57,000 grant from City of Austin




Learning to Coexist with Coyote

#### Coyote sightings in Travis County

Texas Wildlife Services logged 742 reported sightings of coyotes in Travis County from October 2013 to September 2014. The agency removed 61 coyotes in the past year for aggression or where livestock safety was a concern.






Figure 1. Constituent reports of coyote activity received December 2004-March 2007

#### Do Not Feed Wildlife



- Feed pets indoors; store pet food indoors
- Position bird feeders so coyotes and their prey (squirrels and rodents) can't get to the seed
- If you have fruit trees, collect the dropped fruit
- If you compost,
  - make sure compost is secure from coyotes and their prey.
  - avoid putting meat scraps in the compost.
- Secure your garbage can lists; if possible, enclose your cans

# "A habituated coyote is a potential problem coyote."



- Suggested hazing techniques:
  - shout loudly
  - clap hands
  - wave arms
  - be as big and loud as possible
  - throw rocks (sticks will do, but rocks are better)
- Items useful in hazing include:
  - a water hose
  - repellent spray
  - paintballs
  - vinegar in a water gun




