



NOW THEREFORE, in accordance with the authority set forth in paragraph 5 of the declaration of Restrictive Covenants of THE OVERLOOK subdivision dated November 21, 1980, the undersigned, William T. Carson, Jack D. Holford and Larry Lynn, do hereby designate and appoint Susan S. Bergstrom, Jayne D. Kidd, Philip R. Presse and Tom Brooks Metcalfe as members of the Architectural Control Committee of THE OVERLOOK subdivision, who shall serve until their successors are designated in the manner provided in the Restrictive Covenants, and who shall assume all of the duties, obligations, rights and privileges of membership on the Architectural Control Committee set forth in the declaration of Restrictive Covenants and all amendments and additions as may from time to time made thereto.

FURTHERMORE, the members of the Architectural Control Committee wish to amend the restrictions to change the address for submission of plans as set forth in paragraph 5 of the declaration of Restrictive Covenants from Overlook Joint Venture, 1405 W. 6th Street, Austin, Texas, 78703 to The Overlook Subdivision Architectural Control Committee, c/o Mr. Philip R. Presse, 5909 Overlook Drive, Austin, Texas, 78731.
