Article X of the Declaration is amended by deleting the next to last sentence in Section 10.3 and substituting a new sentence. The sentence to be deleted is hyphenated below. The sentence to be substituted in lieu thereof is underlined, below:

"This Declaration may be amended during the first thirty (30) year period by an instrument eigned by Owners of not less than eighty percent (80%) of the Lots now in the Development and thereafter by an instrument signed by Owners of not less than saxty-seven percent (67%) of the Lots now in the Development. This Declaration may be amended by Owners of not less than 67% of the Lots as defined in Section 1.5; and the manner of such amendment may be by instrument signed in writing by the owners and/or by vote at a meeting of the membership as provided in the Bylaws."




