All of the units in all of the buildings together with all of the limited common elements and the general common elements of STILLHOUSE CANYON CONDOMINIUMS (the "Project"), a condominium regime created pursuant to that certain Declaration of Condominium Regime of Stillhouse Canyon Condominiums, dated January 13, 1992, recorded in Volume 11600, Page 412, Real Property Records of Travis County, Texas (the "Declaration").

WHEREAS, Declarant, as the holder of all of the percentage interests in and to the Project desires to amend the provision in the Declaration relating to the lien created thereunder.

NOW THEREFORE, Declarant hereby amends Article 7 of the Declaration by adding the following paragraph:

(h) The lien herein reserved shall be subordinate in all respects to a first lien deed of trust.

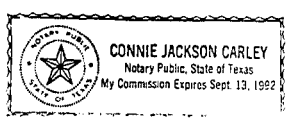
