

## AMENDMENT TO CONDOMINIUM DECLARATION FOR ARCADIA CONDOMINIUMS

KNOW ALL MEN BY THESE PRESENTS:

COUNTY OF TRAVIS

THAT, WHEREAS, a Condominium Declaration (the "Declaration") for Arcadia Condominiums in Austin, Travis County, Texas (the "Property"), was filed May 2, 1984, and recorded in Volume 8574, Page 588, of the Real Property Records of Travis County, Texas; and

WHEREAS, the Declaration was subsequently amended by First Amendment was filed June 13, 1984 and recorded in Volume 8644, Page 670, of the Real Property Records of Travis County, Texas; and

WHEREAS a Supplemental Declaration of Merger and Annexation (the "Supplemental Declaration") was subsequently filed on September 5, 1984 and recorded in Volume 8787, page 234, of the Real Property Records of Travis County, Texas, which Supplemental Declaration added twenty-five (25) units and reallocated the percentage of ownership interest in the Common Areas as set out in Exhibit "C" attached thereto; and

WHEREAS, an error has been discovered in the allocation of certain percentage ownership interests in said Exhibit "C" of the Supplemental Declaration;

NOW, THEREFORE, the undersigned Board members and Secretary of Arcadia Homeowners Association, Inc. hereby verify that the following amendment to the Supplemental Declaration was adopted by the owners of at least 67% of the Ownership Percentage of Arcadia Condominiums and approved by First Mortgagees representing at least fifty-one percent (51%) of the votes attributable to units that are subject to Mortgages held by such First Mortgagees.

Exhibit "C" of the Supplemental Declaration is amended to change the Percentage of Ownership allocated to Unit Numbers 282 and 283 to the following:

The amendment set forth above was adopted on July 22, 1996 at a meeting of Unit Owners of Arcadia Condominium where a quorum was present and was approved by Owners of at least 67% of the Percentage Interests in the Arcadia Condominiums.
