- 3. Paragraph 3.27 is modified to provide for subparagraph f that states: Notwithstanding the foregoing, Lot 8 shall not be subject to any assessments, fees or other liabilities, under a, d, or e above, which relate to the construction, landscaping or upkeep of the entryway of Rico Cove.
- 4. Ratification. Except as expressly modified and amended hereby, the terms and provisions of the Declaration of Covenants, Conditions, and Restrictions for Vista North Section Two-A shall be, and hereby are, ratified and confirmed in all respects.
