



LAS VENTANAS OWNERS ASSOCIATION

POOL AND SPA RULES

The following rules are to be observed by everyone using the pool and spa facilities of Las Ventanas

- 1 Pool and spa facilities are for the use and enjoyment of the owners and residents of Las Ventanas
- 2 Guests are permitted when <u>accompanied</u> by an owner, a tenant or a family member of either the owner or tenant
- Only members of an owner or tenant's immediate family and overnight guests are permitted to use the pool <u>unaccompanied</u> by the owner or tenant
- 4 Children under 12 years of age are not permitted inside the pool fence unless accompanied by an adult
- 5 Children under six years of age are not permitted in the spa at any time
- There is a zero-tolerance for smoking inside the pool fence. Smoking is absolutely prohibited at any time due to the fire hazard. A \$200,00 fee per occurrence will be assessed on any owner found smoking in the pool/spa enclosure. Owners are also responsible for the fees of any resident of owner's property, or any guest of the owner or resident, found smoking in the pool/spa enclosure. If an owner (which term includes a member of the family of an owner, a tenant or guest) we later the rule, the management company shall give the owner written notice of such
 - property, or any guest of the owner or resident, found smoking in the pool/spa enclosure if an owner (which term includes a member of the family of an owner, a tenant or guest) violates this rule, the management company shall give the owner written notice of such violation specifying (i) the nature of the violation, (ii) the fine, and (iii) that the owner has a period of ten (10) days after receipt of the notice to appeal the fine to the Board of Directors. If there is no timely appeal or if the appeal is denied, the fine will be imposed. No cooking smokers or grills are permitted in the pool/spa enclosure due to the fire
- No cooking smokers or grills are permitted in the pool/spa enclosure due to the fire hazard
- 8 Glass of any kind including, but not limited to, bottles, dishes, glasses, serving pieces, etc. are prohibited for safety reasons
- 9 No pets are allowed inside the pool fence
- 10 Proper attire should be worn at all times
- The fountain area is off limits for wading, soaking, sitting, standing, etc because of safety concerns and potential damage to the fountains and lights
- No lifeguards are on the premises. Users of the pool and spa do so at their own risk and the Association is not responsible for accidents or injuries.
- 13 All three spa timers shall be turned OFF after use
- 14 The pool/spa hours of use are only from 6 00 a m until 11 00 p m and the enclosure is off limits at all other times
- Radios/stereos should be battery powered and operated on low volume (headphones are encouraged)

 Be mindful that sounds carry outside the pool area into the neighborhood

While there are no other rules with respect to the spa, your attention is called to the following

- 16 Persons with health related problems should check with their physician for recommended use
- 17 Alcoholic beverages are not recommended when using the spa
- 18 Check the spa temperature prior to entering The temperature will be set on 102F degrees
- 19 The manufacturer recommends limited use of 15-20 minutes
