This Amendment to Restatement of Declaration of Balcones Towers Condominium (the "Amendment") is made to be effective as of May _____, 2007 (the "Effective Date") by the membership of BALCONES TOWERS CONDOMINIUMS, INC., a Texas non-profit corporation (the "Association"), the governing body for the BALCONES TOWERS CONDOMINIUM (the "Condominium"), which was created and exists under the Texas Condominium Act, found in Texas Property Code Section 81.001 et seq. (the "Act").

WHEREAS:

- 1. The Restatement of Declaration of Balcones Towers Condominium (the "Declaration") was executed by the requisite number of Ownership Unit Owners, effective as of March 28, 1988, and recorded in Volume 10705, Page 1804, Real Property Records of Travis County, Texas.
- 2. The Declaration contained the definition and description of the Condominium, the Project Property and each Unit thereof.
- 3. The definition in the Declaration of "Unit" of the Condominium, stated in section 1(f) of Exhibit "A" to the Declaration (found in Volume 10705, Page 1826, Real Property Records of Travis County, Texas), included as its second sentence the following:

"Provided however, that 'Unit' shall not include Unit 119, Building K, which is designated the 'Manager's Unit' and shall be part of the Common Elements'."

- 4. Building K was shown on the survey diagram of the Project Property, included as Appendix "A" of the Declaration (found in Volume 10705, Page 1842, Real Property Records of Travis County, Texas), and the two Units in Building K (Units 119 and 120) were graphically depicted in Appendix "B" on its page 1 (found in Volume 10705, Page 1843, Real Property Records of Travis County, Texas) and on its page 6 (found in Volume 10705, Page 1848, Real Property Records of Travis County, Texas).
 - 5. Section 7 of Exhibit "A" of the Declaration ("Ownership of the Common Elements")

(found in Volume 10705, Page 1829, Real Property Records of Travis County, Texas) listed the respective percentages of undivided ownership interest to be held by each designated Ownership Unit Owner; however, Unit 119 was not listed in Building K, and no undivided ownership interest in the Common Elements was assigned to Unit 119 (due to the exclusion of Unit 119 from the definition of "Unit", as described in section 3 above).

- 6. The Association now desires to terminate the "Manager's Unit" status of Unit 119, as described in paragraph 3 above, so that Unit 119 will become a "Unit" and the future Owner of Unit 119 will become an "Ownership Unit Owner", subject to all applicable provisions of the Declaration.
- 7. Section 32 of Exhibit "A" of the Declaration ("Amendments") (found in Volume 10705, Page 1839, Real Property Records of Travis County, Texas) states the requirements for amendment of the Declaration, requiring written consent of 67% of the Ownership Unit Owners on a recorded amendment instrument.

NOW, THEREFORE, the Declaration is amended as follows:

A. The definition in the Declaration of "Unit" of the Condominium, stated in section 1(f) of Exhibit "A" to the Declaration (found in Volume 10705, Page 1826, Real Property Records of Travis County, Texas), shall hereafter be amended by deletion of the second sentence, quoted in paragraph 3 above, so that section 1(f) will thereafter state only:

"1. Definitions.

* * *

- (f) "Unit" means one of the separate and individual condominium homes into which the Project Property is divided for individual and separate use and ownership as provided for in said Act and described in this Declaration and the plats attached hereto and includes the space encompassed by the boundaries of the Units."
- B. References to Building K, shown on the survey diagram of the Project Property, included as Appendix "A" of the Declaration (found in Volume 10705, Page 1842, Real Property Records of Travis County, Texas), and the two Units in Building K (Units 119 and 120), graphically depicted in Appendix "B" on its page 1 (found in Volume 10705, Page 1843, Real Property Records of Travis County, Texas) and on its page 6 (found in Volume 10705, Page 1848, Real Property Records of Travis County, Texas) will include Unit 119 as a "Unit".
- C. Section 7 of Exhibit "A" of the Declaration ("Ownership of the Common Elements") (found in Volume 10705, Page 1829, Real Property Records of Travis County, Texas), listing the respective percentages of undivided ownership interest to be held by each designated Ownership Unit Owner, will be modified to include Unit 119 and its corresponding percentage of undivided ownership interest, by: (1) deletion of the second sentence in the second paragraph of section 7, and (2) replacement of the chart following the second sentence in the first paragraph of section 7 as shown below. Section 7 will hereafter read as follows:

7. Ownership of the Common Elements. Each Ownership Unit Owner shall also be entitled to the percentage of ownership in the Common Elements allocated to the respective Unit owned by him. Each Unit in Balcones Towers Condominium is hereby allocated the following percentages of ownership in the Common Elements:

The percentages of ownership interest in the Common Elements so allocated to the respective Units are based on approximate relative square footage. Said ownership interest in the Common Elements shall be divided and the Common Elements shall be owned by Ownership Unit Owners, as tenants in common in accordance with their respective percentages of undivided ownership. The Common Elements shall remain undivided and shall not be the object of an action for partition or division of the co-ownership so long as suitable for the condominium regime, and in any event, all

mortgages must be paid prior to the bringing of an action for partition, or the consent of all mortgagees to such action must be obtained. Any covenant to the contrary shall be void. The percentage of the Common Elements allocated to each Unit shall not be separated therefrom or separately sold, conveyed, encumbered or otherwise separately disposed of, and each interest in the Common Elements shall follow the respective Unit to which it is allocated, and shall be deemed to be conveyed encumbered with its respective Unit to which it is allocated even though the description in the instrument of conveyance or encumbrance shall refer only to the Unit.

EXCEPT AS SPECIFICALLY AMENDED IN THIS AMENDMENT, ALL OTHER PROVISIONS OF THE DECLARATION REMAIN FULLY EFFECTIVE AS STATED THEREIN.




