OVER 30 DAYS LATE----\$25 CHARGE

OVER 60 DAYS LATE----LIEN LETTER WILL BE MAILED

3 CONSECUTIVE MONTHS LATE----\$50 PER MONTH

PERMISSION OF MANAGEMENT COMPANY OR BOARD REQUIRED TO WAIVE ANY OF THESE CHARGES FOR GOOD CAUSE

Mesa Forest Association Policies

Rules Enacted By Vote Of Association Members

- 1) Yard Signs: There will be no signs posted in the yards of Mesa Forest (including political & garage sale signs). The only exception will be Realtor signs of a standard size.
- Garage Sales. Garage sales will not be permitted within the subdivision.
 There may be an annual Subdivision-wide garage sale, date to be set by
 the Board of Directors.
- 3) Parking. There is to be no overnight parking on the streets of the subdivision. There is to be no Regular Parking in the driveways; occasional parking in the driveway is permitted.
- 4) Pets. All pets should be on a leash when out in the neighborhood. A pooper-scooper shall be carried to keep the neighborhood clean.
- 5) Limit Of 5 Guests At The Pool At One Time (Other Rules Posted At Pool). Reserving Pool For Party:
 - a. 2 Week Notice
 - b. 2 Hour Limit
 - c. Must Be Finished By 6 pm
- 6) RVs: No Boat Or RV should be kept in the subdivision.

Policies Established By Board of Directors

- \$5 fine for overnight parking on the street
- Late Fees:
 - o 30 days late --- \$25 fine
 - o 60 days late --- Lien letter will be mailed
 - o 3 consecutive months late --- \$50 per month
 - Permission of the management company or Board required to waive any of these charges for a good cause
- Death & Illness Recognition
 - o Illness: When Board Social Chair is notified, a card will be sent
 - Death: The death of a homeowner will be recognized by a planting in their memory. Cost about \$50.
- All HOA Board Of Directors members and committee chairs must be a homeowner in good standing, fees paid on a current basis and following all the rules of the association
- Mesa Forest will maintain a target operating reserve of \$50,000 for 2002 (net of short-term liabilities).
- Mesa Forest BOD will take action to refund money to the homeowners when the amount per home is in excess of \$300 per home or sooner by Board discretion.
