- 2. <u>Survival of Provisions</u>. This Transfer shall bind and inure to the benefit of the parties hereto and their respective successors and assigns.
- 3. <u>Captions</u>. The captions of sections in this Transfer are for convenient reference only and are not to be construed in any way as part of this Transfer.
- **4. Defined Terms**. All defined terms delineated with initial capital letters in this Transfer that are not defined herein shall have the meaning ascribed to them in the Declaration. Other terms have the meanings commonly ascribed to them.


