KNOW ALL MEN BY THESE PRESENTS:

COUNTY OF TRAVIS §

WHEREAS there exists in Travis County, Texas a subdivision known as Northwest Hills Cat Mountain Section Addition, according to the map or plat of said subdivision of record in Vol. 50, Page 86, Plat Records of Travis County, Texas (the Subdivision);

WHEREAS there exist those certain Deed Restrictions benefiting and burdening the Subdivision, being the declarations filed of record at Volume 3978, Page 1332, Deed Records of Travis County, Texas (the "Deed Restrictions");

WHEREAS the Deed Restrictions provide that the Deed Restrictions are fully binding on all persons acquiring property in the Subdivision;

WHEREAS the Deed Restrictions provide that the Deed Restrictions may be amended by a vote of three-fourths majority of the then owners of lots in the Subdivision, each lot or plot to admit one vote; and

WHEREAS the signatories hereto, being at least a three-fourths majority of the current owners of lots in the Subdivision have agreed to amend the Deed Restrictions as set forth herein. THEREFORE,

The undersigned constitute at least the three-fourths majority of the owners of lots in Northwest Hills Cat Mountain Section Addition, a subdivision located in Travis County, Texas, according to the map or plat of said subdivision of record in Vol. 50, Page 86, Plat Records of Travis County, Texas (the "Subdivision").

The undersigned acknowledge, affirm and ratify the Deed Restrictions benefiting and burdening the Subdivision, being the declarations filed of record at Volume 3978, Page 1332, Deed Records of Travis County, Texas (the "Deed Restrictions").

The Deed Restrictions are hereby amended to include the following:

No lot or property (including without limitation, any residence, room or rooms in a residence, any dwelling house, guest quarters, servants quarters, garage, or any other structure located on any lot) in the Subdivision, may be rented for a period of less than 30 consecutive days, and the lessee or lessees under any such rental must use the property as the lessee's residence, and must intend to occupy the property as their place of abode for the duration of the 30 consecutive days.

This amendment shall take effect as of the date filed, and shall continue in effect under the same terms and conditions as stated in the Deed Restrictions referenced above.
