

I, Susie Piaget, Secretary of The Trails Community Association of Austin, Inc. (the "Association"), certify that at a meeting of the Board of Directors of the Association (the "Board") duly called and held on 11/15/2022, with at least a quorum of the Board members being present and remaining throughout, and being duly authorized to transact business, the following Exterior Colors Policy ("Policy") was approved by not less than a majority of the Board members in attendance.

RECITALS

- 1. The property encumbered by this Exterior Colors Policy is that property restricted by the "Amended and Restated Master Declaration of Covenants and Restrictions for The Trails Community Association of Austin, Inc.," recorded in the Official Public Records of Real Property of Travis County, Texas under Clerk's File No. 2012048411, as same has been or may be amended from time to time ("**Declaration**"), and any other property which has been or may be subsequently annexed thereto and made subject to the authority of the Association.
- 2. Article VIII, Section 8.01 of the Declaration authorizes the Association (acting through the Board) to adopt rules and regulations as the Board deems necessary.
- 3. Article VIII, Section 8.01, of the Declaration also authorizes the Association to levy fines against an Owner for violations of the Governing Documents, subject to compliance with notice requirements imposed by law.
- 4. The Board of Directors desires to adopt a policy regulating the exterior colors of Improvements on Lots in the Association. All capitalized terms used in this Policy, but not defined herein, have the same meanings as that ascribed to them in the Declaration..
- 5. This Policy supersedes and replaces any previously recorded exterior colors policy.

EXTERIOR COLORS POLICY

It is the policy of the Association to enforce this Exterior Colors Policy as provided below.

Section 1 Requirements

- 1.1 All exterior work and color choices, even if the color is an approved color, must receive the written approval of the Architectural Review Committee (the "ARC") prior to painting or installation.
- 1.2 Paint brands other than those listed below may be used if they are exact matches to those on the approved list, subject to the prior written approval of the ARC.
- 1.3 Houses shall be painted using one (1) main color that may also be used for the trim color. If a trim accent is desired, one (1) separate trim color may be used. All color choices are subject to the prior written approval of the ARC.
- 1.4 Garage doors shall be painted with either the main house color or the trim color, subject to the prior written approval of the ARC.
- 1.5 Fences may be left unstained or stained using one (1) semi-transparent stain color, subject to the prior written approval of the ARC.
- 1.6 Metal frames for replacement windows may be a color other than an approved color, subject to the prior written approval of the ARC.
- 1.7 Entry doors, not visible from the street, may be painted an accent color other than the approved colors, subject to the prior written approval of the ARC.
- 1.8 Owners doing minor repairs or minor repainting of a portion of a house may be allowed to use the existing color of the house, even if the color is not on the list of approved colors, with the prior written approval of the ARC.
- 1.9 Owners doing substantial or complete repainting of a house or other improvement must use a color from the approved list, subject to the prior written approval of the ARC.
- 1.10 Installations or paint jobs which do not receive the prior written approval of the ARC will be given an opportunity to the cure the violation. Failure to cure the violation may subject the Homeowner to fines in accordance with the Association's Enforcement and Fine Policy.
