The first sentence of Section 27 of the Condiminium Declaration shall be changed to read as follows: The Managing Agent or if there is no Managing Agent, then the Board of Managers, shall obtain and at all times maintain a policy or policies of fire insurance, with extended coverage, in a company or companies authorized to do business in the State of Texas, in the amount of . the full insurable value (determined annually on the anniversary date of each such policy) of all Condominium buildings, fixtures, equipment and personal property comprising the Condominium Regime and shall obtain and at all times maintain any and all other insurance coverage against such other risks as may be now or hereafter customarily covered with respect to other condominium regimes in Travis County, Texas, of similar construction, design and use. (The remaining provisions of Section 27 shall remain unchanged.)
