AMENDMENT TO CONDOMINIUM DECLARATION  
FOR SHADOW OAKS CONDOMINIUM

WHEREAS, on the 30th day of August, 1973, there was filed for record a condominium declaration for Shadow Oaks Townhouses, (a condominium), said declaration being filed of record in Volume 2, Page 478 of the Condominium Records of Travis County, Texas, and

WHEREAS, the undersigned owners of condominium units within Shadow Oaks Townhomes representing an aggregate ownership interest of more than sixty per cent (60%) of the general common elements thereof, and all of the holders of first lien deeds of trust covering or affecting any or all of the condominium units, wish to amend the said declaration in the following particulars, to-wit:

1. Section 1 "Definitions" is amended to read in Subsection (h) as follows:

"Association of unit owners "Association" means the Shadow Oaks Townhomes Condominium Association, Inc., a non-profit corporation, its successors and assigns, the bylaws of which shall govern the administration of this condominium regime, the members of which shall be all of the owners of the condominium units.

2. The bylaws attached to the Declaration as Exhibit "C" are amended to provide that wherever the name "Shadow Oaks Townhomes Condominium Association" appears, the name shall be changed to "Shadow Oaks Townhomes Condominium Association, Inc."
3. Article II, Subsection 3 of the bylaws is amended by inserting "A-1" after the word "Exhibit" in line 3 thereof, which designation was not filled in at the time of the original recording of such declaration and bylaws.
