 Section 1 "Definitions" is amended to read in Subsection (h) as follows:

"Association of unit owners "Association" means the Shadow Oaks Townhomes Condominium Association, Inc., a non-profit corporation, its successors and assigns, the bylaws of which shall govern the administration of this condominium regime, the members of which shall be all of the owners of the condominium units.

- 2. The bylaws attached to the Declaration as Exhibit "C" are amended to provide that wherever the name "Shadow Oaks Townhomes Condominium Association" appears, the name shall be changed to "Shadow Oaks Townhomes Condominium Association, Inc.".
- 3. Article II, Subsection 3 of the bylaws is amended by inserting "A-1" after the word "Exhibit" in line 3 thereof, which designation was not filled in at the time of the original recording of such declaration and bylaws.
