All building foundations on slopes of 15% and over and on fill placed upon such slopes shall utilize design and construction practices certified by a registered professional engineer qualified to practice in this field and such designs shall be on file with the City of Austin Engineering Department.
- 2. For a minimum travel distance of 25 feet from the roadway edge driveway grades may exceed 14% only with specific approval of surface and geometric design proposals by the Director of the Engineering Department or his designee. (Reference varience request considered with plat)
- 3. No fill on any lot shall exceed a maximum of four (4) feet in depth. Except for structual excavation, no cut on any lot shall be greater than four (4) feet.
- 4. The restrictions of this agreement are derived from City of Austin, Texas Ordinance No. 800103 P. In the event that said ordinance becomes less restrictive concerning building foundations, building sites and driveways this covenant shall be amended to follow such less restrictive ordinance, but in the event that such possible ordinance changes become more restrictive the restrictions of this covenant shall remain in effect. This agreement may be modified, amended, or terminated only by the majority vote of a quorum of the members of the City Council of the City of Austin, and joined by the then owner or owners of 51% of the above described property at the time of such modification, amendment or termination. modification, amendment or termination.
