THIS AMENDMENT ONE TO THE ENABLING DECLARATION AND MASTER DEED FOR ESTABLISHMENT OF A CONDOMINIUM REGIME FOR NEELY'S CANYON CONDOMINIUMS ("AMENDMENT"), is made on the date hereinafter set forth, by the Owners of Neely's Canyon Condominiums, and is as follows:

INTRODUCTION

The Property shall consist of the land and eleven (11) buildings constructed or to be constructed on the land, containing a total of one hundred twenty-six (126) residential units thereon, together with other improvements now or hereafter erected thereon, facilities and appurtenances thereto and all property, personal or mixed, intended for use or used in connection with the Property, which Property is further described on the revised Exhibit "A" attached hereto and incorporated herein by reference for all purposes.

ARTICLE II

CONDOMINIUM UNIT DESIGNATIONS AND DESCRIPTIONS

2.2 DESIGNATION OF UNITS

The Property is hereby divided into one hundred twenty-six (126) separately designated units contained within the buildings. Each Unit is identified by number and each building is identified by letter on the Map. The remaining portion of the Premises, referred to as the Common Elements, shall be owned in common by the Owners. The Units, the Buildings, and the Common Elements are hereby amended as reflected on Exhibit "B" attached hereto and incorporated herein by reference for all purposes. The Owners of each Unit shall own an undivided interest in said Common Elements, the percentage or fraction thereof for each Unit being as shown on the revised Exhibit "C", attached hereto and incorporated herein by reference for all purposes.

Notwithstanding anything in this Amendment or the Declaration to the contrary, the Declaration shall be amended only at a meeting of the Unit Owners at which the amendment is approved by the Owners representing an aggregate ownership interest of at least sixty-seven percent (67%) of the Common Elements and no such amendment shall be effective until it is approved in writing by sixty-seven [67%) of the holders of any recorded first lien mortgage covering or affecting any or all Units. No amendment to the Declaration may alter or destroy a Unit or a Limited Common Element without the consent of the Owner or Owners affected and the Mortgagee or Mortgagees of the Unit or Units owned by such Owner or Owners.


LOFT FLOOR PLAN


