WHEREAS, by document dated December 16, 1976, of record in Volume 5676, Page 1595, et seq., Deed Records of Travis County, Texas, Green Trails Estates, a joint venture by and between Donald D. Reynolds, Dorr E. Hampton and Glenn W. Casey, restrictive covenants were impressed on all lots in the Resubdivision of Green Trails Estates, a Subdivision in Travis County, Texas; and,

WHEREAS, in Article II, paragraph M. of such restrictions, the restrictive covenants recited that a residence built on Lot 29, in Block "C", shall be set back 25 feet from the front property line; and,

WHEREAS, the subdivision plat for such subdivision indicates a building setback line for the said Lot 29, in Block "C", of 15 feet; and,

WHEREAS, a residence has been erected on the said Lot 29, in Block "C" which has been set back 15 feet from the front property line; and,

WHEREAS, it is the desire of the undersigned developers and owners of lots in such subdivision to amend such restrictive covenants so that a residence on Lot 29, in Block "C" shall be required to be set back 15 feet from the front property line;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

The undersigned original developers of the Resubdivision of Green Trails Estates and the undersigned owners of the lots in such subdivision do hereby mutually amend the restrictive covenants for the Resubdivision of Green Trails Estates so that a residence erected on Lot 29, in Block "C", of such subdivision shall be set back 15 feet from the front property line.

The restrictive covenants originally impressed on all lots in this subdivision as above stated shall remain in full force and effect and shall remain valid as originally written except for this amendment amending the front setback line for Lot 29, in Block "C", of such subdivision.
